#### 3.3. WORLD UNIVERSITY ARCHERY CHAMPIONSHIP - CORDOBA 2012

### 1. Archery Technical Committee

In accordance with the FISU Regulations, there shall be a Technical Committee (CT) for each sport in the Universiade program.

The Archery Technical Committee shall consist of:

Delegates of the First Technical Committee Meeting will nominate candidates for three (3) additional positions of the Technical Committee. From the nomination list, three (3) experts will be selected and approved in the First General Technical Meeting. Not more than two members of Technical Committee should be from the same country/region.

### 2. Technical Regulations

#### 2.1 General Terms

*The sports events of the 2012 World University Championships shall be organized in accordance with the most recent technical rules of the appropriate FSIs unless otherwise stated by the Executive Committee (FITA Constitution and Rules, 1 April 2011).*

##### 2.1.1 Technical Regulations

*The archery competitions will be organized in accordance with the most recent technical regulations of the Fédération Internationale de Tir à l'arc (FITA). In any dispute, the English text will be regarded as authoritative (FITA Constitution and Rules, 1 April 2011).*

*The programme and duration of the competitions are fixed by the Executive Committee in agreement with the Organizing Committee and the CTI. The competitions will last three days and will include:*

I. Individual events:

Men:                   - Recurve bow  
                              - Compound bow

Women:               - Recurve bow  
                              - Compound bow

II. Team events:

Men:                   - Recurve bow  
                              - Compound bow  
Women:               - Recurve bow  
                              - Compound bow

III. Mixed Team events:

- Recurve bow  
- Compound bow

Each country/region is allowed to enter a maximum of twelve (12) competitors as follows:

I. Individual events:

maximum three (3) competitors in each bow category

II. Team events:

- In each bow category, one (1) team of three (3) competitors selected on their best score in the individual qualification round. Only sixteen (16) best scored teams will be allowed to compete in the elimination phase.
- If a country/region is unable to present a compound bow team for either men's or women's events, it will be allowed to present a mixed **gender** team to compete in the men's compound bow event (1 man + 2 women, or 2 men + 1 woman). The selection criteria will be determined by the competition rules.
- For the Team events the sixteen (16) best teams of three (3) competitors selected by adding the best score of the three (3) competitors of the same country/region, obtained in the individual qualification round will be able to compete. The competition format for this team competition will be:
  - Recurve Bow: the "Academic Round" **shot at 70m** with the hit/miss target **face, with cumulative scoring** (check with the FITA rules-Academic Round)
  - Compound Bow: Compound Round with the 50 m hit/miss target face, **with cumulative scoring** (check the FITA rules-Compound Round).

### III. Mixed Team events:

- In each bow category, one team of two (2) competitors, one (1) male and one (1) female selected on their best score in the individual qualification round. Only sixteen (16) best scored mixed teams will be allowed to compete.
- For the Mixed team events the sixteen (16) best teams of two (2) competitors (one male and one female archer) selected by adding the best score of the best female and best male of the same country/region, obtained in the individual qualification round will be able to compete. The competition format for this team competition will be:
  - Recurve Bow: the "Academic Round" with the hit/miss target **face at 70m** (check with the FITA rules - Academic Round)
  - Compound Bow: the Compound Round with hit/miss 50 m target **face** (check with FITA Rules - Compound Round)
- The archers to shoot the elimination phase can be the same that make the qualification or any other that the delegation will appoint for the Academic Round (Recurve Bow) or Compound Round (Compound bow). Once selected both archers, male and female that will represent the delegation of this country/region (deadline, before the warm up of this competition start), these selected archers cannot be replaced.

*Note: Mixed Team: One male and one female must be from the same country/region and same bow division.*

*At the first General Technical Meeting, the Head of Delegation or his representative shall confirm and sign the official list of the competitors accredited by the CIC.*

## **2.2 Competition Rules**

### **2.2.1 Recurve Bow**

The men and women qualification round shall be conducted in each recurve bow category. Then the individual events will be followed with Olympic round and team events will be followed with Academic round.

#### **Qualification Round (70m Round)**

Each archer will shoot 72 arrows (2x36 arrows) and ends of six arrows. The top 48 individuals, the top 16 teams and the top 16 mixed teams selected based on the points of each archer from the Qualification Round shall advance to the Elimination Rounds. Only in positions of cut (48), one arrow shoot-off. If still a tie, then the arrow closest to the centre of the target face will resolve the tie.

#### **Individual Eliminations (1/24, 1/16, 1/8) and Individual Finals (1/4, 1/2, Bronze & Gold)**

The top 48 archers seeded according to their positions in the Qualification Round (check with match-play chart) should shoot against each other with the winners moving onto the next round.

In the Finals the eight winning archers will shoot against each other in the 1/4 finals of individual events with winners moving onto the semi-finals. The semi-final winners will shoot for gold and the losers will shoot for bronze.

Each match will consist of a maximum of five sets of three arrows. Each set won gives two set points, tie gives one set point, and lost gives zero set point. The first archer to reach six set points will win and advance to the next round. If after five sets, there is a tie, one arrow shoot-off, which is closest to the centre of the target face will determine the last point to win the match.

Except for the matches to be shot in the FOP for Finals, all individual matches can be done with "non-Alternate" shooting, 20 sec per arrow (if time allows it). These will be decided and confirmed by the CT Archery.

### **Team Eliminations and Finals (1/8, 1/4, 1/2, Bronze & Gold)**

The top 16 men and women teams will take part in the team eliminations and finals. Each team will shoot 24 arrows (four ends of six arrows, two arrows per archer) for each match. Each hit scores one, and each miss scores zero. After four ends, the team winning the higher score will win. If after the 24 arrows the score is tied, each archer of the team shoots one arrow. If the score is still tied, then the winner is the team with the arrow closest to the center.

Except for the medal matches to be shot in the FOP for Finals, all individual matches can be done with “non-Alternate” shooting. These will be decided and confirmed by the CT Archery.

### **Mixed Team Eliminations and Finals (1/8, 1/4, 1/2, Bronze & Gold)**

The top 16 mixed teams will take part in the Mixed Team eliminations and finals. Each team will shoot 16 arrows (four ends of four arrows, two arrows per archer) for each match. Each hit scores one, and each miss scores zero. After four ends, the team winning the higher score of the match will win. If after the 16 arrows the score is tied, each archer of the team shoots one arrow. If still tied, a second end is shot. If still tied, a third end of one arrow per archer is shot and the winner is the team with the arrow closest to the center.

Except medal matches, all individual matches can be done with “non-Alternate” shooting. These will be decided and confirmed by the CT Archery.

### **2.2.2 Compound Bow**

The men and women qualification round shall be conducted in each compound bow category. Then the individual events will be followed with Compound Round and team events will be followed with 50 m Hit/Miss.

### **Qualification Round (50m Round)**

Each archer will shoot 72 arrows (2x36 arrows) and ends of six arrows. The top 48 individuals, the top 16 teams and the top 16 mixed teams selected based on the points of each archer from the Qualification Round shall advance to the Elimination Rounds. Only in positions of cut (48), one arrow shoot-off for score. If there is still a tie, then the arrow closest to the centre of the target face will resolve the tie.

### **Individual Eliminations (1/24, 1/16, 1/8, 1/2, Bronze & Gold)**

The top 48 archers seeded according to their positions in the Qualification Round (check with match-play chart) should shoot against each other with the winners moving onto the next round.

In the Finals the eight winning archers will shoot against each other in the 1/4 finals of individual events with winners moving onto the semi-finals. The semi-final winners will shoot for gold and the losers will shoot for bronze.

Each match will consist of five ends of three arrows, with cumulative scoring. The archer with the higher cumulative score will win and advance to next round. If after the five ends, there is a tie, one arrow shoot-off, which is closest to the centre of the target face will determine who wins the match.

All medal matches should be done in alternate format of shooting, 20 sec per arrow.

### **Team Eliminations and Finals (1/8, 1/4, 1/2, Bronze & Gold)**

The top 16 men and women teams will take part in the Team Eliminations and Finals. Each team will shoot four ends of six arrows (two arrows per archer) for each match with cumulative scoring. Each hit scores one, and each miss scores zero. The team with higher cumulative score after the four ends will win. If after

the four ends the match is tied, each archer of the team shoots one arrow to break the tie. If the score is still tied, then the winner is the team with the arrow closest to the center.

All medal matches should be done in alternate format of shooting.

### **Mixed Team Eliminations and Finals (1/8, 1/4, 1/2, Bronze & Gold)**

The top 16 mixed teams will take part in the Mixed Team Eliminations and Finals. Each team will shoot 16 arrows (four ends of four arrows, two arrows per archer) for each match. Each hit scores one, and each miss scores zero. The team with higher cumulative score after the four ends will win. If after the four ends the match is tied, each archer of the team shoots one arrow to break the tie. If still tied, then the winner is the team with the arrow closest to the center.

Except medal matches, all matches can be done with “non-Alternate” shooting. These will be decided and confirmed by the CT Archery.

The scoring in the Qualification Round will be done by the archers. One archer will write down the score on the paper score sheet and another archer will score on a HHT (Hand Held Terminal). The third and fourth archer verifies that the correct scores are entered.

## **6. Protocol and Ceremonies (OC)**

### **6.1. Opening Ceremony**

All teams are requested to be in the Archery field at 19:45 wearing the official teams uniform.

Opening Ceremony will start at 20:00 with a marching of the teams, different opening and welcome speeches, flags raisings and a entertainment show. The total duration of the Opening Ceremony is 35 to 40 min, while archers will be seated the last 15-20 minutes.

### **6.2. Award & Medal Ceremonies**

Award Ceremonies will follow FISU regulations and will be conducted after the conclusion of the last gold medal match of the evening.

### **Mixed Zone and Press Conferences:**

Please make all your archers and officials aware that interviews might take place in the mixed zone or Media areas.

## **7. Medical Related issues (Medical Representative)**

### **7.1 Medical Services**

First Aid Services will be available at the archery venue during competition times.

There is a doctor in available 24 h in the Campus area. May you need her services, please ask to the Front desk to find her.

### **7.2 Emergencies**

In case of emergency during your stay in the Campus, please inform immediately the Doctor of the event. She will take the necessary actions.

## **8. Doping Control**

### **8.1 Doping control**

Doping control will follow FISU-World Archery Rules.

Your athletes should bring their passports and accreditation cards to the doping control station if they are chosen for a test.

## **9. Other Matters of Importance** (WA ED)

### **9.1. Accreditation Cards**

The accreditation card must be worn at all times in the practice and competition areas. Only athletes competing in certain stages of the event are allowed on the Field of Play, together with their coaches. Your cooperation in ensuring only the correct athletes are on the Field of Play would be appreciated as it will make a better event for all.

### Article 3.13.2.1:

An intention to appeal when it might affect the progression of an athlete from one stage of the competition to the next, must be expressed in writing and lodged with the Chairperson of the Tournament Judge Commission and/or the Jury within 5 minutes of the end of the relevant round or match, whichever comes first. The written appeal must be lodged with the Jury within 15 minutes of the end of the relevant round or match, whichever comes first, to allow the Jury to come to a decision before the beginning of the next round of the competition.
