#### 2 TECHNICAL ASPECTS OF THE COMPETITION

There will be two awards:

- South American Championship: Only athletes from member associations of World Archery in South America registered through the WAREOS system will be eligible.
   Medals will be awarded only based on the results of the qualification round.
- 2. Open Competition: All registered member associations of World Archery using the WAREOS and Open WAREOS systems are eligible. Medals Will be awarded for the Individual And Team Olimpic Rounds (Mixed Team and Teams).

Teams will consist of athletes registered through the WAREOS system and, if necessary, will be completed with athletes from the same country registered in Open WAREOS.


## 2.2 COMPETITION SCHEDULE

The current version of the schedule, as of writing this document, is **Version 1.7 (October 8, 2023, 07:23 UTC)**. Please frequently check the competition's web link on IANSEO for the latest schedule updates, as changes may occur during the week.

#### 2.3 PRACTICE FIELD AND COMPETITION FIELD

The competition field is located at the Alberto Spencer Stadium on Av. De Las Américas.

#### 2.4 EQUIPMENT INSPECTION

Equipment inspection will be conducted during the official practice, however it will not be limited to that day. At the discretion of the judges, random equipment inspections may be conducted on any athlete during the competition.

All athletes and officials must wear their uniforms and accreditation credentials.

We recommend that Team Leaders check beforehand that their athletes' details, such as name, date of birth and competition category, are correct.

Inform the technical delegate Vladimir Domínguez or the results manager Juan Sánchez.

Athlete numbers will be handed out on the day of the qualification round during practice.

#### 2.5 QUALIFICATION ROUND AND ELIMINATIONS

Target assignments will be published on IANSEO.

In the morning shift, the recurve division competes in the classification in AB-CD format. In the second round the compound division competes in ABC format.

Targets will NOT be changed after practice sets. During the session, the targets will be changed only if the judges so require. Please instruct your athletes to mark all arrow hits during practice and competition.

Sessions will begin on time. When there are no scheduled practices, matches will begin as soon as the field is ready. Athletes should be alert and ready in case their matches start earlier than scheduled.

In the case of bye, athletes will be allowed to shoot at their own target, provided that the competition program allows it. Athletes who shoot in a direct pass will do so respecting the time and signals of the DOS of the competition. In direct passes, recurve archers are allowed 3 practice sets and compound archers 5.

#### **APPEAL PROCEDURE** 2.6

An appeal form is attached to this document.

In the case of an intention to appeal or an actual appeal, the times indicated on the Appeal Form must be observed.

Appeal forms must be submitted to the Head of the Tournament Judges Commission (Roy Cortes) or his substitute.

A fee of 50 USD (or 50 EUR) must be paid for the appeal to be valid.

If the appeal is upheld by the Appeal Jury, the fee will be returned. If the appeal is rejected, the fee will not be returned.

#### 3 **RESULTS**

IANSEO will be the results system. Scoring in the Qualification and Elimination Rounds will be done by the archers. The score will be recorded on the scorecard and another archer will score on a "partial scorecard" that will be given to the results team volunteers at the end of each set. Portable digital instruments (PDA) will not be used.

Remind your archers that they must complete the scorecard with the total 10's and X's and with the respective signatures.

#### 4 TECHNICAL MATTERS (TD + PRESIDENT OF JUDGES)

#### 4.1 TIME CONTROL SYSTEM

The timing equipment will consist of two digital timers located at the sides of the shooting field.

#### 4.2 WARM-UP AND START OF THE COMPETITION

The warm-up is always scheduled for 3 practice sets. Once the practice is completed, the competition will begin immediately.



#### 4.3 ARCHERS ACTING AS COACHES

Archers may act as coaches during the finals, but they must request confirmation from the judges. A new accreditation will not be issued.

#### 4.4 EQUIPMENT FAILURE IN THE QUALIFICATION ROUNDS

No extra time will be granted for equipment failure or medical issues, but the athlete in question can leave the shooting line to resolve the problem and return to shoot any remaining arrows if the time limit allows.

## 5 LOGISTICAL ASPECTS (TRANSPORT)

Airport-hotel-airport transportation will only be provided to delegations/participants who have requested and booked it through Wareos.

For delegations/participants/officials staying in official hotels, daily transportation will be provided from the hotels to the Alberto Spencer Model Stadium and vice versa starting on October 9th (non-official practice).

#### 6 MEALS

Breakfast and dinner will be served at the hotel. Lunch will be served at the sports complex where the competition will take place from October 9 to 14.

#### 7 ACCREDITATION CARD RULES

Accreditation cards must be worn at all times during practice and competition.

All participants of the South American Open Championship, Guayaquil 2023, including athletes, officials, judges, and staff, must complete the official accreditation process.

Accreditation will be conducted at the facilities of the Alberto Spencer Model Stadium.

During the accreditation procedure, identities will be verified, and payments and other administrative matters will be confirmed.

The accreditation card is the only valid credential for access to the competition venue, official buses, hotel, dining area, etc. Without official accreditation, participation in any official activity related to the championship will not be allowed.

ACCREDITATIONS WILL NOT BE ISSUED AT ANOTHER LOCATION.

#### **8 MEDICAL ASSISTANCE**

First Aid will be present at the shooting range to provide medical assistance.

#### 9.3 NON-SMOKING AND NO ALCOHOL

This is a non-smoking event. Smoking inside the stadium is strictly prohibited. Smoking is only allowed outside of the instalations.

All lost items will be taken to the DoS (Director of Shooting) stand, so please inquire there if you have lost something.
